

As Christmas approaches, we look forward to celebrating the birth of Jesus Christ, a time that reminds us of God's love, hope, and the promise of peace for all. As a Church school, we reflect on the true meaning of this season – the gift of Christ's birth and the light He brings into the world. Through our Carol Service, Choir recitals and nativity performances, we have together as a community to share in the joy, kindness, and hope that Christmas brings.

The <u>first marble nativity scene</u>, seen above, is often attributed to the renowned Italian sculptor Arnolfo di Cambio, who created it around 1291 for the Basilica of Santa Maria Maggiore in Rome. This work marked one of the earliest representations of the nativity in stone, setting a precedent for later depictions in marble and other mediums. Di Cambio's craftsmanship combined religious devotion with artistic innovation, influencing nativity scenes across Europe.



We would like to extend our heartfelt thanks to our Local Committee member Mike Tomlinson from the Baptist Church for kindly volunteering his time to read with our Year 5 pupils this week.

The children thoroughly enjoyed his visit, and we are delighted that he will be joining us weekly from January to continue this wonderful support.

Please help us have a great Christmas and a lovely Christmas dinner.



ATTENDANCE

Penalty Notices

Penalty Notices (fines) can be issued to each parent liable for an attendance offence.

Under Section 576 of the Education Act 1996 a 'parent' includes any person who is not a parent of the child but who has parental responsibility, or who has care of the child.

Penalty Notices can be used where the pupil's absence has not been authorised by the school and there are at least 10 unauthorised absences in a 10 school week period (these absences do not have to be consecutive).

The amount payable under a Penalty Notice (PN) is as follows per parent, per child

Absence Category	0 - 21 Days	22 -28 Days	More than 28 Days
First Absence since 19 August 2024	£80	£160	Prosecution
Second Absence (within 3 years of first Penalty Issue date)	£160	£160	Prosecution
Third Absence (within 3 years of first Penalty Issue date)	N/A	N/A	Prosecution

ATTENDANCE

Informing School of Absences

A reminder to parents/carers to please call the school office if your child will not be attending school between 8:30-9am.

This helps us ensure all absences are accounted for and keeps our records up to date.

Recently, it has been taking up to an hour to follow up on unreported absences, so your cooperation in notifying us promptly is greatly appreciated.

Please also ensure the correct evidence is provided (please see below). If we do not receive this, a fine may be issued.

Absence reporting procedures

If your child is absent as a result of illness, please phone us **between 8:30-9am** on 01483 273286 on the first day of absence, and each subsequent day, to let us know the reason.

Within 5 working days of your child's return following illness, the below will be required in order to authorise their absence due to illness:

- A signed/stamped letter, appointment card, text or email dated to the time of any GP/nurse appointment
- · A receipt showing any medication bought and/or a dated prescription medication label

If your child is absent due to a medical or dental appointment, you must present one of the following either before or after (within 5 working days) their absence:

· A signed/stamped letter, appointment card, text or email dated to the time of the medical/dental appointment

What Parents & Carers Need to Know about

SETTING UP NEW DEVICES FOR CHILDREN

At Christmas, millions of lucky children will be excitedly ripping the wrapping off new phones, tablets, computers or consoles. However, in the rush to let young ones enjoy their shiny gadgets, many parents neglect to set these devices up safely – increasing the chances of children going online and stumbling across adult content, making expensive downloads or installing unsuitable apps. A little time configuring the device properly can save a lot of anguish later. Here are our top tips to ensure that a dream gift on Christmas morning doesn't turn into a nightmare by New Year.

PASSCODES FOR IPHONE/IPAD

If your child's getting their own iPhone or iPad, you can set parental controls that make it difficult for them to access inappropriate content or download expensive apps. Once the device is set up, go to the Settings app and tap Screen Time, then select Use Screen Time Passcode and enter a passcode. Keep it to yourself so your child can't switch the protection off.

SCREEN TIME SETTINGS ON

Once you've set a
Screen Time Passcode,
you can adjust various
safety settings. You could, for
example, only allow communication
with people from the Contacts app, place
restrictions on App Store purchases and
apply age limits to movies, music and
web content. There are many more
protective options available within the
Screen Time settings section.

FAMILY LINK FOR ANDROID

Parents can manage Android phones and tablets, as well as Google Chromebooks, through Google's Family Link app.
This gives your child some independence (and their own Google account) but lets parents monitor which apps are being used, set limits on content and ensure that parental permission is required to install apps. Look for Family Link in the Google Play Store.

ADD A CHILD TO FAMILY LINK

The easiest way to add a child's device to Family Link is to set it up with its own Google account. It's a good idea to create this before they use their new phone, tablet or Chromebook. Once they're logged in, open the Family Link app on your phone, press '+' in the top right and add a new family member using their Google account details. Then follow the on-screen instructions.

FAMILY SHARING ON A MAC

Families using a Mac get similar screen time options to iPhone and iPad users. Again, if you're setting up a Mac for a child, make yourself the main admin and add them as a user. This is handled through Apple's Family Sharing service, which not only allows you to put controls on child accounts but share apps and other purchases with them too. Search 'family sharing' at https://support.apple.com.

The same control settings you use for a PC can be used to apply parental controls on an Xbox. Again, once your child is signed into the Xbox with their own account, you can then monitor and regulate their activity from a PC or web browser. Microsoft's dashboard allows you to manage voice communication through the console: so you can limit who can

PLAYSTATION PARENTAL CONTROLS

DISCUSS IT WITH YOUR CHILD

If you're planning to implement any kind of restriction or protection settings on your child's new device, we'd recommend having a discussion with your young one first about what these controls do, and what they are for. If you try to impose parental controls surreptitiously or with no advance warning, don't be surprised if your child tries to find a way around them.

INSTALL XBOX FAMILY SETTINGS

If you don't have a PC, but your child does have an Xbox, it might be easier to use the Xbox Family Settings app for iPhone or Android. Here, you can restrict console screen time (particularly handy if the console is in a bedroom), restrict communication and monitor the types of game being played. There's also a feature where you can allocate spending money for games or in-game purchases.

STAY VIGILANT

parental controls – not least because what's unacceptable to some parents is perfectly acceptable to others. So although devices' parental controls will help to keep your child safe online, they work best side by side with good old-fashioned parental vigilance.
